### **CALL FOR XX EDITION OF "FESTIVAL CORTO CIUDAD REAL 2018"**

The Call is being open by Local Government of Ciudad Real, through its Youth Council, in order to set of participation rules in this XX Edition of the "Festival Corto". The aim is to recognize and promote the creativity in short-films sector and become our city in an example in this field. So, this Call is open for the year 2018, and its rules are the following.

#### **RULES.**

The gaming rules of the Call were approved by Local Government Meeting on 16th January, 2017, and they were also published in Official Bulletin of Ciudad Real province, number 11, on 18<sup>th</sup> January, 2017.

#### **AIM.**

The aim of this Call is to award prizes in the world of short-films in order to recognize and promote creativity.

#### **FUNDING.**

An amount of 10.200,00 € will set aside for the current Call. This total amount will be assigned in the Budget number 2312 22625 "Other expenses in Festival Cortos Ciudad Real" in the General Budget extended of the Local Government of Ciudad Real in 2018.

#### **CATEGORIES.**

Three participation categories are established:

- FICTION: free subject fiction works.
- DOCUMENTARY: free subject documentary works.
- ANIMATION: free subject works done by any animation techniques.

Two different SECTIONS are established: The OFFICIAL one is for finalist works which aims for the different prizes, and NON-OFFICIAL one for works which have been selected for being showing, not to aim for a prize.

The OFFICIAL SECTION will be composed of four finalist works for every CATEGORY, and also three works directed or produced by local authors.

All of these works will receive the amount of 300€ as finalists, and they will compete for the following prizes:

**Best Short Film**, awarded with 1.500€ and trophy.

**Best Documentary Short Film**, awarded with 1.000€ and trophy.

**Best Animation Short Film**, awarded with 1.000€ and trophy.

**Best Local Short Film**, awarded with 700€ and trophy.

**Prize “Young Producer”** for the best finalist short film directed by under-35 years producers, awarded with 500€ and trophy.

**Audience’s Prize** for the non-local work which best-voted during projection in OFFICIAL SECTION, awarded with 500€ and trophy.

**Special Prize for the Best Female Director**, awarded with 500€ and trophy.

Voting classification will be established through the best arithmetic mean as a result of divide the total scoring by number of voters.

**Local Mention from the audience**, for the work which receive more votes, with trophy but without economic prize.

### PARTICIPANTS AND CONDITIONS.

1. The participation in this festival is open to all of authors born or resident in Europe or Latin America.
2. The works can not exceed 30 minutes, titles included. Only works produced after 1st January 2016 and not taken part in previous edition will be admitted.
3. Maximum two works for author.

4. The same work can not compete in more than one category.
5. The works must be presented in Spanish or in original version but with Spanish subtitles.

With the aim to be available for all kind of audience and with a special attention for deaf people the works should have readable subtitles for deaf people.

6. The Selection Committee will choose those short-films which take part in each category (Official and non-official ones).

All of selected Works in any category will be showed during the Festival Week.

7. Youth Council in Local Government of Ciudad Real reserves the right to reproduce the participant works in non-profit cultural activities, and also to use details of the works to promote the events in the media, always citing the author.
8. It is not necessary to confirm the conditions established on 13<sup>th</sup> article of General Grant Law, "Ley General de Subvenciones", to compete for the prize and due to the feature of the grant.

### FESTIVAL CELEBRATION:

- WORKS ADMISSION: from 2<sup>th</sup> February to 14<sup>th</sup> March.
- PARTICIPANTS LIST PUBLICATION FOR OFFICIAL SECTION: 16<sup>th</sup> April.
- PARTICIPANTS LIST PUBLICATION FOR NON-OFFICIAL SECTION: 21<sup>st</sup> May.
- FESTIVAL CELEBRATION: from 18<sup>th</sup> to 23<sup>th</sup> June.

Short-films of the NON-OFFICIAL SECTION will be showed in the different places of the festival during 18, 19 and 20 June.

Short-films of the OFFICIAL SECTION will be showed in "Quijano" Local Theatre on 21<sup>th</sup> and 22<sup>th</sup> June.

- FINAL DECISION OF WINNERS, PRIZES-GIVING AND CLOSING CEREMONY OF THIS 19<sup>TH</sup> EDITION: on 23<sup>th</sup> June.

### **REGISTRATION AND DOCUMENTATION.**

The registration is only online, in the following platforms:

- MOVIBETA
- CLICKFORFESTIVAL

Besides digital short-film, participants must to upload:

- Three quality photographs of the short-film/filming.
- Official poster of the work.
- Director's digital Identity Card copy.
- Participants who opting to local prizes must justify his/her residence or birth in Ciudad Real by an official document.

Any interesting information (links to trailers, works Webs, director's filmography, press kit...etc.) is recommended.

Mailing and delivered by hand will not be accepted.

Online registration costs will be paid by participants.

### **WORK DEADLINE.**

The due date is from 2th February to 14th March 2018, after the Call extract has been published in Official Bulletin of the Ciudad Real province through the National Grant Database, such as it is established by 20<sup>th</sup> article of the General Grant Law 38/2003 ("Ley General de Subvenciones 38/2003").

### **SELECTION COMMITTEE AND JURY.**

The Selection Committee will be formed by Local Government manager staff and its job will be the selection of Works for Official Selection or Non-Official one.

Prizes and special mentions for finalist works will be given by a Jury. The judges will be cinema and culture independent professionals and their decisions will be final. With

the exception of "Audience's Prize" and "Local Mention from the audience" that will be given by audience's votes during show session.

The jury's decision and the rest of prizes and mentions will be announced in the Closing Ceremony, on 23<sup>th</sup> June, in "Quijano" Local Theatre in Ciudad Real.

The representatives of finalist short-films and the Special Mention Director must be met in the arranged place on the morning of Saturday, 23<sup>th</sup> June, this being an essential requirement for obtaining the corresponding prize, as well as for the coverage of the expenses generated.

Besides Closing Ceremony and award ceremony, organization staff will have prepared different activities for all of the attendants.

The accommodation of the attendees will be covered by the Festival Organization in a hotel in the city: a double room per work, under the SA regime

The representatives of finalist works are the directors; they only can be replaced by any of these posts in the work: the author of the original idea or writer, photograph director, producer, main actor or actress, or the original soundtrack producer.

Furthermore, we will thank the attendance of any finalist short-film representatives in order to promote them during the event. Your accommodation is also covered

### **CONDITIONS FOR SELECTION.**

Both Selection Committee and Jury will follow a quality and suitable criteria to select the works.

### **PRIZES PAYMENT.**

Economic amount and prizes will be given in an only payment, alter Award and Closing Ceremony, when award-winning had given necessary information for it.

Prizes will be subject to tax retention according to Spanish taxes legislation.
